Daycare Records Notice:

IT IS HEREBY FURTHER ORDERED, pursuant to R.C. 3319.051(I), the parties hereto are hereby notified as follows: Both parties are entitled to access to any day care center that is or will be attended by the children with whom visitation is granted, to the same extent that the other parent is granted access to the center.

Student Activities Notice:

IT IS HEREBY FURTHER ORDERED, pursuant to R.C. 3319.051(J), the parties hereto are hereby notified as follows: Both parties are entitled to access, under the same terms and conditions as the other parent to any student activity related to the children and to which the other parent of the children legally is provided access.
